

**COMMERCIAL PERFORMANCES BY THE LEGAL REGISTER CENTRE**

Pursuant to section 9 of the Act on Criteria for Charges Payable to the State (150/1992) and section 3 of the Decree on performances subject to charge by the Ministry of Justice and certain other authorities in the administrative sector (1745/2015), the Legal Register Centre hereby adopts the following charges for the commercial performances mentioned below. Performances by the Legal Register Centre priced on commercial grounds shall be subject to the fixed charges mentioned below or in their stead, charges determined on grounds mentioned separately.

**Section 1**  
**Registers under private law**

In respect of data in machine-readable registers, the following charges are made to users for printouts concerning a single person or matter:

A charge of EUR 0.66 plus VAT of EUR 0.16, price including tax thus coming to EUR 0.82, will be made for separately organised services in which the customer is only provided with information as to whether the business prohibition Register on Bans on Business Operations or Register on Bankruptcies and Reorganisations contains data pertaining to a debtor.

**Section 2**  
**Mass disclosure of data from registers under private law**

In respect of lists compiled from register data or one-time disclosure of data comprising several persons or matters in machine-readable format, the following charges are made to the recipients of disclosure for each person or matter included in the disclosure and for each disclosure occasion separately:

**Section 3**  
**Exercise of right to review personal data**

When a private individual or an entity exercises its right under the Personal Data Act (523/1999) or section 6(4) of the Act on Criminal Records Act (770/1993) or preservation or disclosure of information on criminal records between EU Member States (214/2012) to review its personal data, a charge of EUR 30 plus VAT of EUR 7.20, coming to a total of EUR 37.20, will be made for the data disclosed if less than one year has elapsed from the previous review by that party.

**Section 4**  
**Photocopying and delivery charges**

**Section 5**  
**Other performances**

Training provision services shall be priced individually for each course provided.

Publications shall be priced individually for each publication.

Person-work relating to data retrieval and disclosure for scientific research or corresponding purpose is charged at EUR 50.93/hour + VAT at 24%.

**Section 6**  
**Collection of charges**

Charges made shall be paid immediately upon delivery of performance or within 14 days of delivery of invoice to the recipient of the performance. Delivery of an invoice sent by post to a party liable to pay is deemed to take place on the seventh day after the invoice was consigned to the post for delivery. Lawful penalty interest and any collection costs arising to the State will be charged on past-due invoices.

The charges mentioned above in section 1 shall be made by the party which the Legal Register Centre has authorised to disclose data to users.
